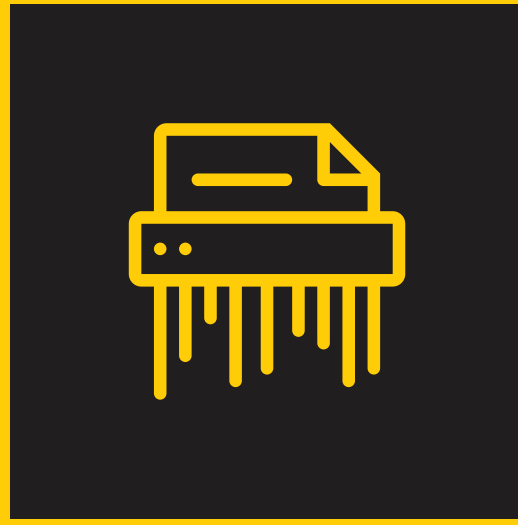
### LAW ENFORCEMENT AND FORENSICS
